**Development Services Director/Staff Report and Discussion** - Michael Ciriello was not present but Chair LaPlante discussed the meeting that was held for the Agricultural Summit. The date for the Summit is March 2, 2019. The theme is “How can you make your farm viable in the future.” The purpose is to raise awareness of agriculture in the region. Joan Nichols attended the meeting. They need to give it a name – possibly The Connecticut River Valley Agricultural Summit. This will be discussed further before a decision is made. Potential Topics and sponsors discussed were – Finance/Insurance, Farm Credit, Nationwide Insurance, Family and Estate Planning, produce safety, marketing, how to promote tobacco, fruit and vegetables, social media. branding, how to start a CSA and what are local grocery stores and restaurants looking for, technology ie, using charge cards, swipes, etc. Approximately five topics/repeat three times. A mock 4 hour timeline was setup – possible breakfast/coffee and danish from 9 – 9:45 – break into groups for workshops approximately 45 minutes each until lunch time - break for lunch have a keynote speaker and questions and answers. They will be looking for sponsors for breakfast, lunch, etc, hopefully locals will step up to offer. Jaime Smith will be helping out also. There needs to be a concrete take away for attendees. The next meeting is June 19<sup>th</sup> at 4 PM in the Enfield Room.
